- Ensure ongoing evolution and flexibility of the Integrated Management System in order to adapt it to the changing internal and external context;
- Ensure the appropriate resources to address the risks and opportunities identified;
- Provide training to the staff to help them perform their tasks correctly and safely while increasing productivity and reducing costs in compliance with the regulations and regulations in force from time to time;
- Empower and involve the staff to raise awareness of their contribution to the requirements of the Integrated Management System;
- Improve internal effectiveness and efficiency through performance measurements, data analysis, internal information, and customer/market return data.

Specific objectives will be defined annually for the Company management related to the responsibilities covered and the contribution of each one in relation to the general objectives of the CBI within the scope of the relevant activities.

As a further guarantee of the Management's commitment, this Quality and Environmental Protection Policy will be reviewed annually to determine its long-term suitability and will be redrafted, if necessary, with a view to continuous improvement on the basis of the defined corporate objectives and strategies.
